ARRIVAL OF THE NEW CHILEAN AMBASSADOR

His Excellency Rear Admiral (R) Kaare Olsen, newly appointed Chilean Ambassador to the Court of St. James, accompanied by Madame Irene Hornsby de Olsen, arrived in London on November 3rd, and are staying at the Residency at 92 Eaton Place, S.W.1. On behalf of the Lord Chairman, Committee and Members of the Society, we offer them a warm welcome and wish them a long, happy, and most successful stay in this country.

The Ambassador is by no means a stranger in Britain. During his long and distinguished career in the Chilean Navy and Government, he has paid it several visits and made many friends here. The first occasion was in 1928, when, as a Sub-Lieutenant of the Chilean training ship Corvette "General Baquedano", he arrived at Dartmouth under sail from Chile. On that occasion he was also present at the launching at Southampton of the destroyer "Riquelme", one of six built there for the Chilean Navy.

Twenty years later, he was appointed Naval Attache to the Chilean Embassy in London and remained here for the two years 1948-

He joined the Chilean Naval School as a cadet in 1921. Details of his outstanding long service are too numerous to publish here; suffice it to say that he did not retire from the Navy until 1957, when he had reached the high rank of Rear Admiral.

During the regime of President Ibanez, he took an active part in Government and was appointed Minister of Education and Minister of Foreign Affairs in 1955, his actuation in these important posts being notably successful.

Both the Ambassador and Madame Olsen were born in Iquique, Northern Chile, and were married in 1932. They have one daughter and a son. Madame Olsen is of British descent, her father being Scottish and her mother English. They have visited England, accompanied by their daughter, on many occasions.

In a private interview, His Excellency affirmed that he is glad to be in England again and to be reunited with the many and good friends he made here during his long career.

CHILEAN NAVY DAY

The customary ceremonial laying of a wreath on the tomb of Lord Cochrane in Westminster Abbey was carried out on May 21st, jointly by H.E. the Chilean Ambassador and Rear-Admiral Oscar Buzeta C.V.O.

A number of members of the Chilean Embassy, officers of the Chilean Naval and Air Force Missions with their ladies and a number of persons connected with Chile were present at this solemn traditional ceremony and religious services.

NAVY DAY RECEPTION



CREATION OF AVIATION MISSION IN LONDON

It has been announced that the Chilean Air Force by Decree No.400 of the Ministry of Defence has raised its London representation from that of an Air Attache to "Chilean Air Force Mission in London".

The Mission, now under the control of the Air Attache Col. Fernando Matthei, will be permanently based in London but will act as buying agents in Europe as a whole.

CHANGES IN CHILEAN GOVERNMENT

A complete change of Government in Chile was brought about on September 11th. last by the united Chilean Armed Forces, who together deposed President Allende. He met his death during an attack on the Presidential Palace "La Moneda" on that date. Shortly after the takeover a military "Junta" comprising the four

Commanders-in-Chief assumed power, headed by General Augusto Pinochet Ugarte (Army), with Admiral Jose Toribio Merino (Navy), General Gustavo Leigh (Air Force) and General Cesar Mendoza (Carabin eers).

A predominantly military cabinet was then formed, since when a number of changes have taken place and its composition is now as

Congress was dissolved and the activities of all political parties

The country's borders were closed on September 11th., but were re-opened on the 18th of that month. A street curfew was at first imposed, which has now been eased.

On October 1st the exchange control system was modified and rates simplified to only two quotations per U.S. dollar, namely 280 escudos for trade operations and 850 escudos for tourism.


These rates have been modified subsequently to 285 and 800 Escudos respectively, and tourists have been relieved of the obliga-tion to exchange a minimum amount of US \$10 per day for the period of their stay in the country.

THE SWORD FUND

In a recent issue of Chilean News attention was drawn to the traditional presentation of swords ceremony which takes place annually in Santiago when four swords of honour are awarded to Cadets of outstanding merit from each of the Chilean Armed Forces as gifts from the Society in London.

This traditional event has continued for the past 30 years but owing to increasing costs purchasing the swords became too onerous for the Society last year and it was found necessary to ask for help from the Santiago Committee to be able to continue the ceremony.

Fortunately, such help was received and the customary presentations duly took place in Santiago in December last. It was obvious however that the same problem of financing the purchase of swords would arise each year and after careful consideration the Executive Committee decided to establish a "Sword Fund" and to appeal for donations to finance future annual awards.

Accordingly, our Chairman, Lord Aldenham addressed a circular letter to all members in May last inviting them to contribute to this special fund and it is gratifying to report that up to now some 45 donations have been received amounting to a total of £396. The fund will remain open for further contributions and it is hoped that we shall shortly have sufficient funds to finance the cost of swords for at least two years. OBITUARIES

Fernée, T. A. We record with deep regret the death of this member on 10th March, 1973, in hospital.

"TAF" as his closest friends called him went out to Chile in 1922 for Grace Brothers of London and after some years in Nitrate Agencies at Antofagasta he joined Cia. Sud. Americana de Explosivos (a subsidiary of I.C.I. of London and Du Pont, U.S.A.) becoming their Chief Accountant in Valparaiso Head Office and later in 1948 Company Secretary and Treasurer. He continued with this Company, which transferred its headquarters in 1955 to Santiago, until his final retirement in 1963 when he returned to England to live in Grayshott, Surrey.

He gave his services willingly to many Community Committees in Chile, in particular as Treasurer of the Church, Seaman's Mission, Commonwealth Society and at one time a Governor of McKay's School. He was also a devoted Freemason, belonging to three Lodges in Chile and during 1942 and 1943 was Master of the "Star and Thistle" Lodge 509 of Valparaiso. He was a member of the Anglo Chilean Society for twenty-two years.

To his widow, Mrs Constance Fernée and a son, Philip, we extend our deepest sympathy.

Cowley, Charles. With much regret we record the decease of this old member on February 13th, last, in England, at the advanced age of 88 years. He had been a Member of the Society practically since its inception in 1944. Nearly the whole of his career was spent with the Antofagasta (Chili) and Bolivia Railway Company Ltd., his first contract commencing in January 1906, when he was 21, at Antofagasta, which port he reached by steamboat via the Straits of Magellan. At that time the railway to Bolivia was considered to hold the record of being the highest in the world. On his return to England he continued in the Company's service for the rest of his working life, broken only between 1917 and 1919 when, after some weeks spent in France, he was seconded to the British Embassy in Madrid. He became Secretary to the Railway Company in 1929 and joined the Board of Directors in 1941, remaining thereon until just before his seventieth birthday in 1954, thereafter as a consultant.

A member of the Institute of Chartered Secretaries and Administrators for over 60 years and a Fellow of the Institute of Directors for 24 years, he was wonderfully active, both mentally and physically right up to the moment of his death, which was instantaneous.

Montgomerie, F. J. D. Francis James Dudingston Montgomerie, a founder member of the Anglo Chilean Society, died at Leatherhead Hospital on May 16, 1973, in his 83rd year.

'Dudingston' and the terminal '-ie' in the name betoken a Scottish family background of which Montgomerie was justly proud. After schooling at Aldenham, he was apprenticed to an engineering firm fitting him well for service in the Royal Engineers which he joined immediately on the outbreak of war in 1914. Initially Montgomerie was a despatch rider but later was commissioned and attained the rank of Captain. When a Lieutenant, he was mentioned in despatches and was awarded the Military Cross for meritorious service. Montgomerie's love of soldiering again found outlet in the second world war when he became a keen and highly competent officer in the local Home Guard.

But it is not of Montgomerie in war that I would write, but rather of his long and devoted service to the nitrate industry of Chile. This extended continuously over a period of some forty years from 1920 or thereby when he joined one of the Aikman companies until his retirement from the Nitrate Corporation of Chile Limited in 1960.

Many will remember the difficult and uncertain days of the reorganization of the nitrate business in the late 1920's and early 1930's with, among other changes, the formation of Chilean Nitrate of Soda Distributors Limited in 1928. The short-lived "Cosach" followed in 1930 and thereafter came Chilean Nitrate Producers Association (London) Limited subsequently named Nitrate Corporation of Chile Ltd as it remains today.

Throughout these vicissitudes "Monty", as he was familiarly called, was always at some key point where his personal qualities of courtesy, dedication and complete integrity were invaluable. He was in charge of the U.K. sales section of the C. N. D. consortium and secretary of the company; and on the formation of Chilean Nitrate Producers Association and its renamed successor he became head of the Insurance Department where he remained in control until his retirement.

A man of great charm, Montgomerie's considerable gifts were enhanced by a distinction of appearance and manner which lent emphasis and dignity to everything he did. Like most men of his generation destined to carry responsibility he was a stern critic of all that was slipshod, careless, undisciplined; but his temperament was too well adjusted ever to let him behave unreasonably or unkindly.

No tribute to "Monty" would be adequate without a reference to the endearing qualities of his wife who helped and supported him throughout, and to whom he was so devoted. To her, and to his two daughters and their children we offer our warm and affectionate sympathy.
