GOOD NEWS FROM CHILE ON THE ECONOMIC FRONT

CHILEAN PESO REVALUED

On 6th March Chile again revalued her currency by 10%, fixing the parity of the Peso at 17.77 to the U.S. dollar, (from 19.75 per dollar) as part of a package of measures to boost production and combat inflation. This move follows a turn round in Chile's monetary policy in July last year, when the Government, following a long series of devaluations in recent years, decided upon an upward revaluation of 11.2%. This policy of revaluing the Peso is aimed at bringing relief to Chilean industry by reducing the cost of imported machinery and materials.

COPPER

An official announcement from the Comision Chilena del Cobre states that during 1976 the total national production of copper in Chile was 1,005,288 tons. This figure represents an all time record

Another factor of prime importance to Chile is that copper prices have been rising steadily since the beginning of January on the London Metal Exchange. From US\$ 0.59 per lb in December prices have risen to US\$ 0.69 reached on 17th March. This gives an average price of US\$ 0.65 since the beginning of this year.

The Chilean Government budget estimates for 1977 have been planned with a copper price of US\$ 0.60 as a basis for calculations.

CENTRAL BANK OF CHILE RESERVES **REACH RECORD LEVEL IN 1976**

The gross Reserves of the Central Bank of Chile reached US\$ 720 million in 1976 which is the highest level in the history of the Bank million in 1976 which is the highest level in the history of the Bank according to a statement recently made by the President of the Central Bank. Net Reserves showed an improvement of US\$ 476 million in 1976 after payments of over US\$ 800 million in interest and instalments on the foreign debt. These figures reflect a steady improvement in the country's financial position. Chilean exports in 1976 reached a total of US\$ 2,120 million, an increase of 37% on 1975 figures, this improvement heigh levels the second of the levels of t 1975 figures, this improvement being largely the result of a big increase in non-traditional exports which the Government have been encouraging for some time.

PETROLEUM

The state-owned oil Company ENAP has recently announced officially that during 1978 twelve new petroleum wells in the Straits of Magellan oil fields will come into production and that in 1979 they plan to bring between another 24 to 36 wells into production. The statement also indicates that the production capacity of many of these wells will greatly exceed the calculations made during the initial exploration. initial exploration.

FOREIGN INVESTMENT STATUTE AMMENDED

A new Decree has recently been passed by the Government amending Chile's Foreign Investment Statute. The reason given for the modifications was to adapt the Statute to present cay economic conditions, also to adapt it to the new circumstances created by Chile's withdrawal from the Andean Pact (a trade and finance agreement with some neighbouring countries) which contained articles imposing certain restrictions on foreign investment.

The new measures are said to place the foreign investor on equal footing with local business interests, and to give him equal access to foreign exchange for the purpose of remittance of capital or

The substantial changes from the original Statute are intended to

provide a) greater flexibility in the concept of what constitutes foreign investment—thus eliminating some restrictions contained in the old Statute.

b) a considerable reduction in the paper work involved in order to guarantee speed and efficiency in the negotiation process.

c) the guarantee of free access to foreign exchange for remittances—strengthened by the stipulation that when an investor requires foreign currency his application will be treated in the same way as applicants seeking to cover the cost of most imports.

For full details of the many other important changes in the Statute reference should be made to the text of the Decree published in the

'Diario Official' in Santiago.

REDUCTION IN PUBLIC EXPENDITURE

Another important factor in Chile's economic recovery has been the big reduction in Public Expenditure achieved over the past three years. In 1973 total Public Expenditure represented 42.6% of the Gross National Product but under a persistent deflationary policy pursued by the Government this had been reduced to 27.4% of the G.N.P. in 1976.

A truly spectacular achievement paving the way for a healthy reduction in taxation.

280,000 VISITORS TO CHILE IN 1976.

Approximately 280,000 foreign tourists visited Chile in 1976, generating an income of about U.S. \$90 million, according to the Director of National Tourism Service in Santiago.

At a recent press conference the Director, Senora Liliana Mahn,

At a recent press conference the Director, Senora Liliana Mahn, stated that this success is the result of a realistic policy adopted two years ago with the object of attracting tourists from all over the world, but giving particular encouragement to bringing visitors from neighbouring countries.

Factors in this success story were an extensive advertising campaign abroad, and the support given to Local Authorities to develop new facilities in their areas. Special courses of instruction were also held for the police customs efficienced insurable.

were also held for the police, customs officers and journalists throughout the country. It is estimated that the income from the influx of tourists in 1976 was equal to between 3 and 4% of the value total exports from the

country in that year.

ANGLO CHILEAN SOCIETY LECTURES

On the 17th December 1976, Sir Frederick Mason, Vice-Chairman of the Society, was invited to give a repeat of a talk to the Sixth Formers at Bradford Grammar School. Sir Frederick talked about Chile generally with special reference to its social and economic evolution over the years. The boys received the talk with great interest and there was some lively debate at the end of it.

LECTURE ON CHILEAN HISTORY

On the 22nd February Dr. Harold Blakemore, Chairman of the Society and Reader in Latin American History at the University of London, gave a lecture at Canning House entitled 'Myth and Reality in Modern History' In recent years great attention has been given by Latin American and Chilean Historians to the theory of 'dependency' which endeavours to interpret the reasons for underdevelopment in Latin America and other countries. Under this theory, as relates to Chile, some writers tend to consider that Chilean economic development was 'distorted' by the relationship between the Chilean governing classes and foreign capital, after Independence, and during a period when British interests were predominant: Dr. Blakemore considered some aspects of this question, focussing particularly on British enterprise in Chile in the nineteenth century. He said that, contrary to the said theory, British Companies did not exploit Chile's economy, but had to make large investments and wait a long time before making any profit.
